ADDITION TO SCOPE OF WORK

The following items are being added to the scope of work:

- 1. There are twenty-three (23) trees that will need to be removed.
- 2. Contractor shall be responsible for stump removal of all trees removed.
- 3. The new fence that shall be built along the back of the clearing shall match the existing fence that it will come off from. The length of the new fence measures 110 feet.
- 4. The concrete pad shall be 45'x60' instead of the previous area of 50'x60'.
