#### ADDITION TO SCOPE OF WORK

The following items are being added to the scope of work:

- 1. The contractor shall demolish existing 80 feet of chain-link/wood fencing. The supporting posts of the chain-link fence shall be kept at their current placement. A new 6 ft wooden fence shall be built in place of removed fencing. The contractor shall add a 10' x 2' retention board to the new fencing. This work will be prioritized in the schedule.
- 2. Contractor shall include an alternate bid for a full building replacement.
- 3. HVAC system shall be a Trane unit.


Attached is the footprint/drawing of the current barn and site visit list.
